### QE2 UPDATE

#### New Services:

1. **Post Secondary: 4 Year College** – replaces Post Secondary: College - use for all baccalaureate degree programs
2. **Post Secondary: Graduate College** – replaces Post Secondary: College - use for all post baccalaureate graduate programs

**Note:** For clients working on a Graduate Degree or starting to work on a Graduate Degree in the next Financial Aid Year (July 1, 2015) please add the new Post Secondary Graduate College service.

Providers that had Post Secondary College now have the two new Post Secondary Services, 4 Year College and Graduate College.

3. **Post Secondary: Books and Supplies 4 Year College** - replaces Post Secondary: Books & Supplies
4. **Post Secondary: Books and Supplies Graduate College** - replaces Post Secondary: Books & Supplies
5. **Post Secondary: Tools - 4 Year College** - replaces Post Secondary: Tools-College
6. **Post Secondary: Tools - Graduate College** - replaces Post Secondary: Tools-College
  
7. **On-the-Job Training: Job Coach Project Search** (use if we have a service agreement with the job coaches) - **NEW Service**

**Note:** We added this new service to the three job coach provider records that fit this category.

8. **Miscellaneous Training: GED - NEW Service**
9. **Miscellaneous Training: Other Classes - NEW Service**
10. **Miscellaneous Training: Apprenticeship Programs - NEW Service**
11. **Miscellaneous Training: Disability Related Skill Training - NEW Service**

**Note:** Staff will have to add these services to the appropriate providers before they are able to add a provider to the service under the Services Tab.

#### **New Community Services Category and New Services:**

12. **Occupational or Vocational Training: Project Search** (use for all other Project Search clients) -**NEW Category and Service**

**Note:** We added this new service to our Project Search funding partners.

13. **Occupational or Vocational Training: VR Certificate Programs - NEW Category and Service**

**Note:** We know that there are VR Certificate Programs with Central Community College and Metro Community College so we added this service to those two providers. Staff will have to add this service to other providers that provide this service to our clients.

14. **Occupational or Vocational Training: Occupational or Vocational Training - NEW Category and Service**
